w.e.f. 17-09-2020 to 26-09-2020 (with late fee of Rs.320/-)

The Vice-Chancellor may consider grant of late admission for 10 days after the expiry of aforesaid prescribed dates with late fee in respect of both the semesters on payment of fee Rs.2910/-
